## Article 2 of Human Trafficking Prevention Act :

I (1) :

Refers to the use of rape, coercion, intimidation, detention, surveillance, drugs, hypnosis, fraud, intentional concealment of important information, improper debt restraint, withholding important documents and other **methods against the person' s will** with the intention of causing people to involving in **Sex trafficking, Work in which labor and remuneration are obviously not commensurate, or to Harvest other people 's organs**, which engaging in recruiting, buying and selling, pledging, transporting, delivering, accepting, hiding, hiding, intermediary, sheltering domestic and foreign people, or using the above methods to engage in sex trafficking , **Work in which labor and remuneration are obviously not commensurate**, or harvesting of organs.

I (2) :

Refers to the intention to cause a person **under the age of 18** to commit the above-mentioned acts, regardless of **whether it is against his or her will or not**.

# Xinzhuang Precinct

## Labor Exploitation Case

**Date : March 30, 2021**

## Summary:

The Suspect Cai and others recruited undocumented migrant worker, then restricted and monitored their freedom of movement, forcing the victims to work according to their instructions and exploiting the proceeds of their labor. This case was discovered by Xinzhuang Precinct, NTPD, NPA and New Taipei Specialized Operation Brigade, NIA .

## Pattern of Crime:

**Because Suspect Cai's girlfriend was an Indonesian, so he had easy access to get in touch with the undocumented Indonesian migrant workers, who were lack of financial resources.**

After recruitment, they strictly controlled the victims' freedom of movement to prevent the victims from seeking help from outside the country.





**Date : March 14, 2022**

The Suspect Ke and others recruited the undocumented migrant workers to engage in sex trade, then conduct sexually exploitation on them. The whole case was discovered by Sanchong Precinct, NTPD, NPA and Chiayi Specialized Operation Brigade, NIA .

Suspect Ke and his Vietnamese girlfriend and others formed a prostitution organization **to recruit Vietnamese women to come to Taiwan in the name of migrant workers to engage in sex trade**. Then they controlled the victim in a Beauty Salon and forced them engaging in sex trade according to their arrangement. After receiving the information, the police start a judicial investigation and finally arrested Criminal Ke and other 8 people.

## Luzhou Precinct

### Attempted Organ Harvesting Case

#### Summary:

Date : January 6, 2023

The Suspect Chen and others lured Taiwanese citizen to Cambodia on the pretext of work with the intention of forcibly harvesting their organs for profit. The whole case was discovered by Luzhou Precinct, NTPD, NPA and Criminal Investigation Bureau, NPA.

#### Pattern of Crime:

Chen and other suspects had connections with a crime group in Cambodia and were promised to get rewards by trafficking victims abroad to sell the victims' organs. Chen and others recruited victims with false reasons and sent them to Cambodia, luckily the victims got on the wrong car so they were not caught by the crime group and came back to Taiwan safely. The police soon arrested Chen and other suspects.

## Shulin Precinct

### Child and Youth Sexual Exploitation case

#### Summary:

Date : July 9, 2023

Gangster of Ming Ren Hui used intimidation, sex videos and drugs to control underage girls to engage in sex trade for profit. The whole case was discovered by Shulin Precinct, NTPD, NPA , TCPD, NPA and Criminal Investigation Bureau, NPA.

#### Pattern of Crime:

The suspects and others searched for underage girls through minors in the gang, and initially used threats to force the underage girls to engage in sex trade according to their arrangements. **After several times, they began to threaten the girls with drugs or sex videos to continue engaging in sex trade.** The victims were **unable to break away from gangsters' control and afraid to ask for help even though they were unwilling.** After receiving the intelligence, the police start a judicial investigation and finally arrested the suspect and 10 other people.

竹聯幫仁堂明仁會南新莊分會伍姓幫眾，涉嫌與同夥及多名少年誘拐5少女賣淫，並以毒品控制少女，伍男還以性侵犯及其前女友拍攝的性愛影片，威逼誘拐前女友下海賣淫，檢警初估不法獲利近達百萬，新北地檢署已依違反《兒少性剝削防制條例》等罪起訴伍、樺二男，其他涉案少年則移送少年法庭審理。

據了解，綽號小胖的伍姓男子（19歲）自稱是明仁會南新莊分會成員，今年3月6日，伍男曾參與明仁會在北市萬豪酒店舉辦的賣淫餐敘，並以黑幫身分招募軍中的中職生加入幫會，多次於新北市轄內將械鬥滋事。

檢警調查，伍男指使旗下瓜姓少年等人，在網路上以高薪徵才為由，誘拐少女應徵，或利用少女邀家等機會慫恿其下海賣淫，共計有5名少女加入伍男所組的賣淫集團，伍男等人再透過網路聊天或交友軟體嫖客，以每次6千元到2萬元不等價格從事性交易，由成員送往指定地點
